The guidance notes in this series are intended to be easy-to-use summaries of current good practice for some of the animal welfare issues that local Ethical Review Processes (ERPs) have to address. However, we hope they will prove useful to ERP members in general, and to other types of animal care and use or ethics committees around the world.

Introduction

Good animal welfare goes hand in hand with good quality science [see **FELASA**, below], so there is considerable benefit to reducing animal suffering and providing a good quality of life for laboratory animals. This principle should be applied to the lifetime experience of the animals - to housing and care, transport, handling and restraint and euthanasia, as well as to experimental procedures. However, identifying good practice is not always easy - Codes of Practice may present minimum standards, not good practice; there may be a plethora of information in the scientific literature; or relevant material may not be very accessible.

These guidance notes summarise the available information on a selection of topics to help those not expert in the field to understand and contribute more to ERP discussions. They are intended to be dynamic, and are updated as knowledge about animal behaviour and welfare progresses. Visits to the animal facilities and discussions with relevant staff such as the Named Veterinary Surgeon (NVS) and Named Animal Care and Welfare Officer/s (NACWOs) are also important and the notes should be used in conjunction with these activities.

- Housing and care for a range of species. These give a 'feel' for the nature of the animals to set their needs in context, then they list most important housing and care requirements, with a focus on providing environmental enrichment. The guides do not cover the physical environment for each species, since this is adequately covered in the Home Office Codes of Practice. Neither do they address specific veterinary or health issues, or the welfare issues arising from the research for which the animals are used.
- Good practice for humane killing. This includes principles of humane killing, refining Schedule 1 methods, making decisions about non-Schedule 1 methods and a summary of current knowledge about the use of CO₂.
- Cage cleaning: Mice and rats. An overview of current thinking on cage cleaning protocols to minimise stress.
